MSL Signs 5-Year UK POS Agreement with ASM Global

Highlights

- **MSL signs 5-year point-of-sale (POS) agreement covering 22 large event venues in the UK operated by ASM Global, including arenas and racecourses in Manchester, Leeds and Newcastle**
- **Agreement broadens MSL's existing relationships with international venue operator ASM Global, which already sees MSL provide solutions to several of ASM's entertainment and convention centres across Asia Pacific, within ASM's broader network of over 300 venues across five continents**
- **Contract generates majority upfront software, hardware and services revenue along with support services revenue over the initial 5-year term, with total contract value of £1.96 million (~AUD\$3.5 million). The deal will increase MSL's recurring revenue by £188k annually (~AUD\$335k) for the 5-year term.**

Sports, leisure and hospitality SaaS technology provider MSL Solutions Limited (ASX: MSL, "MSL" or "the Company") is pleased to advise that the Company has signed a multi-year contract with leading global venue and event management company, ASM Global, to provide mobile point-of-sale (POS) solutions to 22 ASM venues across the United Kingdom.

The contract, signed through the Company's UK operation, MSL Verteda Ltd, will see ASM Global install over 900 terminals operating Kappture POS software, extending ASM's POS capabilities through mobile devices and mobile apps across their UK arena and racecourse portfolio. The platform will enhance guest engagement at ASM venues and deliver a superior experience for guests, event staff and venue managers.

The deployment will see some of the UK's most iconic sports, leisure and entertainment venues convert across to MSL and Kappture's stadium-specific POS solution, including:

- The 21,000-seat AO Arena in Manchester
- The 13,000-seat First Direct Arena in Leeds
- The 11,000-seat Utilita Arena in Newcastle
- The P&J Live Arena in Aberdeen, Scotland's largest entertainment venue
- The York Racecourse, an iconic horse racing venue in North Yorkshire

The contract will see MSL earn a combination of upfront software, hardware and services revenue plus annual support revenue over the initial 5-year term, with total contract value of £1.96 million (~AUD\$3.5 million).

The contract builds upon MSL's existing relationships with ASM Global, Australia's largest venue operator, which in September 2020 saw the parties agree to a 5-year POS agreement covering RAC Arena in Perth, Australia.

ASM Global, which is headquartered in Los Angeles, operates a diversified portfolio of more than 300 facilities across five continents, including arenas, stadiums, convention and exhibition centres, performing arts centres, theatres and other venues. The company also has corporate offices in London, Brisbane, Manchester and Sao Paulo.
